

Green Liberty Caucus: Why have a caucus?

Why should there be a Liberty Caucus and what value could it offer to the Green Party, nationally, statewide and locally? What is the purpose of liberty?

A caucus is a group with a fixed interest that engages for a political purpose. The Green Party allows members to organize "identity" caucuses for historically underrepresented groups. A Caucus may send up to three delegates to participate in National Committee affairs and vote on policy. A Caucus is a channel for activism and party building activity.

A Liberty Caucus is an invitation to every state in the country, every county and city and local area, to the people therein, to organize cells that would do the work of speaking truth to power, defending liberty by calling out malfeasance, and building the Green Movement by way of championing the cause of justice to hold government and corporations accountable.

Liberty guards against tyranny. But no individual should have to push for liberty alone. A Green Liberty Caucus functions as a community of voices that frame the issue of liberty in the context of calling out malfeasance that violates the law, constitutional rights, and Green 10 key values.

So, while a Liberty Caucus is against malfeasance and corruption, it proactively seeks accountability as the antidote to what has become chronic problem of elite impunity which shows up as state crimes against democracy and secondarily, environmental catastrophe from global warming as well as the gross unjust economic distribution of wealth.

Greens are opposed to corruption in all its manifestations. We demand accountability on many fronts; we demand transparency in government and corporate affairs. Most concerning, is the overuse of national security protocols that make government affairs opaque.

Secrecy orders conceal endemic corruption associated with the military industrial, Big Pharma / medical complex and the Big Money

banking complex.

As Greens we are duty bound to respect the 10 Key Values and other platform positions the Party has adopted. However, we don't believe achieving the Green vision is possible without justice, or some kind of accounting for malfeasance, presently and from the past.

The purpose of our government as enshrined in the Constitution is to *promote the general welfare*. However, as has been well documented, government is largely owned by a plutocratic oligarchy that is behind the Big Pharma/ Big Money/ Military Industrial Complex. In a new bout of malfeasance, this cabal endeavors to enact a vaccine health registry of the people and thereby expand its controls over society in the guise of the Covid public health emergency.

Moreover, the adage to follow the money to discern motive, reports show Big Pharma has earned billions on the Covid 'pandemic'. Mandating vaccines and annual boosters drive profits and is the root of the corruption within Big Pharma / USA government agencies.

Democracy and liberty require the bravery of whistleblowers, and whistleblowers require independent media to disseminate the news.

By this means, we the people may learn about corrupt acts that violate the law and preclude liberty from being manifest in society. A Liberty Caucus seeks protections for whistleblowers.

A Green Liberty Caucus is primarily concerned with government and corporate malfeasance and its impingement on the democracy; therefore, the caucus seeks ways to end corruption and end the impunity by which the plutocratic corporate oligarchy carries out its affairs.

To that end, a Liberty Caucus provides a political home for critical but mostly dissident voices that have a keen eye for identifying inappropriate behavior and have a passion for justice.

A Green Liberty Caucus can heal the divisions within the Green Party.

The Green Party has been weakened by conflict over what and who gets to be defined as Green. To heal these ruptures, the Caucus would provide a clearing within the movement for a tolerant and inclusive place to grapple with our divergent and dissident voices.

A Green Liberty Caucus would welcome the contingent from Dialogue Not Expulsion that faced off with other Greens over sex-based versus gender based rights. A Green Liberty Caucus could function as a big tent structure and would create space for differences to be discussed without fallacies and antidialogical rhetoric. Irreconcilable differences should not necessarily be cause to expel; however, there should be tests to assess whether controversial positions violate 10 key values or not. People should agree to disagree and continue the struggle toward building a just and green society.

On another contentious matter, the Green Party Steering Committee issued a statement that favors *vaccine mandates, travel passports, and quarantines*; the statement was obviously intended to dissuade anti-mandate Greens from arguing the point, but the matter blew up.

The Black National Caucus issued an anti-vaccine mandate statement which comprehensively calls out problems with the Federal Covid response. A Green Liberty Caucus would naturally align with the BNC over its liberty stance opposing Covid Mandates, and by this means create intersectionality within the Green Movement and foster dialogue and work toward understanding and Movement Building.

The point here is that the Caucus structure enables minority voices to be well expressed, and these voices add to our democratic process and the stuff of being Green. The notion that the Green Party could be a unity of diversity, and become a major party across the country eludes us because we fail to foster a diversity of sensibilities; instead, the Party has focused on expelling and excluding, and not reconciling with divergent opinions.

A Green Liberty Caucus is the place for Greens who value medical freedom, are deep naturalists, anti-technocracy people, anti-totalitarian dissidents, people opposed to the plutocratic Globalist project, people opposed to technocratic controls including vaccine

passports; people with these sensibilities will all find a home in a Green Liberty Caucus and not be canceled out with derogatory and fallacious remarks.

In theory, every political party in the country and Europe and other places, should have a Liberty Caucus that stands against corruption and for basic constitutional rights, humanitarian values, human rights, and of course, the 10 Key Values.

What holds Greens back, and many others in society from demanding justice for state crimes and mobilizing against the injustice of it all?

Why are so many of us compliant, trusting of our government leaders, and unwilling to question much less challenge what are obviously false narratives?

These are very complicated questions but fear is at the bottom of our hesitancy to name the crimes. The country experiences the mass marketing of the "official narratives," which include the deployment of "Big Lies" in the guise of False Flag operations, all of which raises the specter of society being subject to a psychological operation conducted through FBI / CIA COINTELPRO. This essay cannot address how mass [consciousness is accomplished](#), but considerable writing explores the issue of mass psychosis and how it is induced in society. With Covid, we appear to be in such a predicament.

When we look to the government for reassurance and confidence, we are sadly looking at a wolf guarding a hen house. The reassurances we get are often Big Lies that cover up the malfeasance.

Consider the 1960's assassinations as a series of traumas and mendacious cover-ups. The cover-ups of the crimes all qualify as psychological operations to control popular thought. Being forced to accept a false narrative is jarring and traumatizing in its own right, and the confusing and shocking nature of the events, induce shock and enable a false narrative to be accepted as truth through a relentless media campaign. This is how doubts about the Warren

Commission Report were handled, and during the events of 9/11 as well.

Consider the history. Though the country was warned by Eisenhower about the Military Industrial Complex, a warning that extended into the CIA and other National Security agencies, the warning was not acted on by the US Congress. This set the stage for Kennedy's assassination.

The consecutive traumas of the 1960's assassinations starting with John F. Kennedy, including Malcolm X; MLK; RFK; Fred Hampton et al, followed by the trauma of the Vietnam War, and the crushed hope for a peace dividend with the 9/11 false flag events, and now a Covid emergency, have all conditioned the nation to accept a manipulated media message that keeps us confused about the truth.

The tendency to dismiss unanswered questions about the Kennedy assassination as "history" or "water under the bridge" about which nobody has any control is a mistake because the ghosts of the assassination haunt us today. Without exorcising the demons we the people remain captive to the gains the plutocracy garnered with each act of malfeasance and each crime against our democracy. Each plutocratic win is a democratic / republic loss.

Underneath these covert crimes, are the daily overt crimes that come from a corrupted judiciary that has eliminated Voting Rights' protections, granted free speech rights to corporations, emboldened the bribery of Congress, and justified the largest upward transfer of wealth to the top .0001%. All this enabled by a failure to put a check on power when the opportunity was present.

In the case of the JFK assassination and the 9/11 events, Congress abdicated its duty to check the power of the Executive Branch.

The covert history of the crimes against democracy needs to be completely exposed before we can demand justice for each act and collectively oppose the civil war against the people of the Republic carried out by the plutocracy.

We now live in a full blown national security / surveillance state without the protection of the 4th Amendment!

How would our history have changed if the assassinations and other crimes by the deep state had been successfully prosecuted?

Without a doubt, had Kennedy and the other slain leaders survived, our nation and its people would have been better off living out of their visions for a fair and equitable society. As Martin Luther King reminded us, "We shall overcome because the *arc* of the moral universe is long but it bends toward *justice*."

We can never know, but it is a fair bet to say the CIA would have been 'broken and scattered to the wind' had Kennedy survived Dallas in 1963.

Instituting the social justice programs Green's value will require achieving electoral and political power. Green's could grow the movement and reach the halls of government by focusing on what has been achieved through illegal means including crimes against our democracy.

Nothing will be accomplished without indicting the ruling class for their crimes so it can be clear to the people that the problems we suffer today are the result of elite impunity to pursue private profit over securing the general welfare for the country.

A Green Liberty Caucus will not shy away from demanding justice, even if the crime is 80 years old, or older as is the cause of all the Native American treaty violations and the failure to deliver 40 acres and a mule promised to African Americans after the Civil War.
